WAIVER AND RELEASE OF LIABILITY
(IMPORTANT - READ BEFORE SIGNING!)

In consideration of being allowed to participate in any way in The 1st Annual NorthEast Kayak Fishing Rodeo, and related events and activities, the undersigned agrees to the following:

1. Prior to participating, if I believe anything is unsafe, I will immediately advise an event organizer of such condition(s) and refuse to participate. I certify that my physical condition and training are adequate to enable me to compete safely in the tournament, and I acknowledge that I am familiar with paddling and the risks involved.
2. Parent/Guardian: As the parent or legal guardian of the participant I will instruct the minor participant that prior to participating, if we believe anything is unsafe, we will immediately advise an event organizer of such condition(s) and refuse to let the minor participate. I certify that the minor's physical condition and training are adequate to enable the minor to compete safely in the tournament, and I acknowledge that the minor is familiar with paddling and the risks involved.
3. We acknowledge and fully understand that each participant will be engaging in activities that involve risk of damage to personal property or serious injury, including permanent disability or death, and severe social and economic losses which might result not only from my own actions, inaction's or negligence, but the actions, inaction's or negligence of others, the rules of play, the condition of the premises, or of any equipment used. Further, there may be other risks not known or not reasonably foreseeable at this time.
4. We assume all the foregoing risks and accept personal responsibility for all expenses, medical or otherwise, following any such damages, injury, permanent disability or death.
5. We release, waive, discharge and covenant not to sue the King Cove Kayak Center, its affiliated organizations, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from any and all liability to the participant, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
6. This waiver may not be modified in any way. If any part of this waiver is determined to be invalid by law, all other parts of this waiver shall remain valid and enforceable.

WE HAVE READ THE ABOVE WAIVER AND RELEASE, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGNED IT VOLUNTARILY.
